Notes to the financial accounts

General

Annual accounts are compiled in accordance with accounting principles generally accepted in The Netherlands. The financial accounts are drawn up in euros.

The principles of valuation and determination of result remained unchanged compared to the prior year.

Activities

European Neuromuscular Centre (ENMC) in Baarn was founded on November 24, 1992 under Dutch law. The objective of the foundation is to promote research in the field of development, prevention and treatment of neuromuscular diseases and to collect and distribute useful and reliable information about these diseases. To meet this objective, the foundation mainly organizes workshops which are its core business. The workshops are held in The Netherlands.

The foundation is financed by a number of National Patient Associations for neuromuscular diseases in Europe and other related organizations. The foundation has its statutory seat in Baarn and holds office in the building of Spierziekten Nederland.

Accounting policies in respect of the valuation of assets and liabilities

General

Fixed assets are valued at acquisition cost less straight-line depreciation over the estimated useful economic life. Receivables are valued at face value less a provision for bad debtors, if any. All other assets and liabilities are valued at nominal value.

Accounts receivable

Other receivables are recognized at nominal value less provisions deemed necessary for doubtful debts. These provisions are determined based on individual assessment of receivables.

Current liabilities

Current liabilities are measured at face value.

INDEPENDENT AUDITOR'S REPORT

Report on the financial statements
