# **Guidelines for authors of full ENMC reports**

The submission of a full workshop paper to the journal of NMD will be treated as a report on an ENMC workshop, with the convenor[s] listed as corresponding author[s]. They will not be subjected to peer review and, after approval by the Editor, will be published in the next available issue of the journal. The workshop report should be concise and follow the agenda of the workshop – it has the nature of a workshop report, not of a review article (see also <u>https://www.nmd-journal.com/content/authorinfo</u>).

The length of a report will vary depending on the number of topics discussed. Workshop reports need to be succinct, focusing on the new information shared. The References should be confined to those directly relevant to the workshop and should follow the format indicated in the Guide to Authors for all submissions to Neuromuscular Disorders. Up to three tables, figures or photos may be included. An abstract of up to 150 words must be included.

# 1.TITLE

The basic format of the ENMC based workshop reports will include a **TITLE** reflecting the number of the ENMC workshop, the topic of the workshop, the date and the location.

## Example:

## 2. AUTHORSHIP

Only the workshop organisers, a maximum of four, and one or maximally two Early career researchers will be the authors of the workshop report. There can also be a corporate author. This could be the workshop participants, who are included in the author list on the first page as "ENMC XXXX Workshop Study Group", and listed individually at the end of the report, with their institute, town and country.

The authors will be included on the first page of the report, under the title, with a similar format to original papers in the journal. A full but preferably brief address can be included for each author, and the corresponding author for proofs and reprints should also be indicated.

Early career researchers may be nominated by the workshop organisers and ENMC to become co-author of an ENMC full report if significant contributions are made to the workshop and its reports. This should be approved by the Editor-in-Chief of Neuromuscular Disorders.

#### **3. AUTHORSHIP OF THE WORKSHOP PARTICIPANTS**

The organisers are to make sure that the tasks of all workshop participants regarding the preparation of the meeting report will have been discussed before and prior to closing the workshop. Presenters will be asked to hand in a half A4 describing the key elements of their talk and the subsequent discussion.

All workshop participants and/or study group should be listed under a separate subheading at the end of the report. Include their name, affiliation/city in brief, and country.

All workshop participants will be included in the "ENMC XXXX Workshop Study Group", so that they can be found in PubMed as co-authors of the workshop report. The workshop participants/report authors will be listed at the end of the report, with their institute, town and country. This list may also include any ENMC representative as appropriate with [ENMC] after their name.

Neuromuscular Disorders and PubMed accept authorship from the Study group. It is important to stress that this request is made upon submission to NMD (Elsevier) with Jane Miller informed as well, to make sure the Study group is indeed correctly coded for authorships in the published manuscript. Tagging of the ENMC workshop participants need to be actioned on Science Direct.

#### 4. ACKNOWLEDGEMENT

Full acknowledgement will be given to ENMC and all its sponsoring organizations at the end of the report using the exact wording as provided by the ENMC office:

#### **5. SUBMISSION PROCESS**

- a) The ENMC office will have to give final approval on the full report and will check the acknowledgements for correctness.
- b) The report can then be sent to Jane Miller, Editorial Office (jane.miller@ucl.ac.uk), who will do a preview

- c) <u>Organisers need to indicate to the Editor-in-Chief (via Jane Miller) if they wish for up</u> to two Early-career researchers, if applicable, and a Study Group to be included in the authorship.
- d) Then the organisers are requested to submit the manuscript to portal Elsevier for publication in Neuromuscular Disorders.

#### 6. PEER-REVIEW

As in the past, these reports will not be subjected to any peer review and it will be assumed that the content has the approval of all participants of the workshop. Once approved by the editor, the report will be given priority publication in the next available issue of the journal.

#### 7. ACCESSIBILITY

Every ENMC workshop report (in PDF) is freely accessible as agreed upon with NMD in the past. In case the PDF cannot be opened after publication please notify Jane Miller who can contact the right people at Elsevier.

**8. KEYWORDS** can be provided for reference.

9. TIMELINES to be followed are (at the latest):

**3 weeks after the workshop:** all presenters hand in synopsis of their presentations (approximately ½ A4) to the organisers.

Within 10 weeks after the workshop: organisers prepare draft full report if feasible in close collaboration with Early-career researchers and patients (patient representatives), who attended the meeting.

**10 weeks after the workshop**: organisers send draft report to all participants, and all participants should review the draft report and send comments to the organiser(s).

**12 weeks after the workshop:** organisers collect all comments from participants and rewrite report.

**16 weeks after the workshop:** send final report to participants, last chance of input.

**19 weeks after the workshop:** send final report to <u>enmc@enmc.org</u> for final check, and verify the acknowledgements

**20 weeks after the workshop:** send approved full report to Jane Miller from NMD (jane.miller@ucl.ac.uk ) with the specific requests mentioned above.

**21 weeks after the workshop:** organisers submit the full report and including figures, tables, key words, references etc.in the NMD portal <a href="https://www.editorialmanager.com/nmd/default2.aspx">https://www.editorialmanager.com/nmd/default2.aspx</a>
